## 1 GENERAL CONDITIONS

- 1.1 Sealed tenders in the form of two bid systems (Technical and Financial proposals in separate sealed envelopes) are invited by Embassy of India, Athens from reputed companies for undertaking Geotechnical survey in connection with redevelopment of the plot of land at 58 Nikifoura Lytra, Paleo Psychiko, Athens for the Residence of Ambassador of India.
- 1.2 The bids should be submitted in prescribed format as laid down in the tender document. The tender documents duly filled in and complete in all respect should be addressed to Mr. Balji Nagrath, Head of Chancery, Embassy of India, No. 3, Kleanthous Street, Athens, 10674 and submitted offline only before 1500 hrs of **January 31, 2025**. Bidding firms or their representatives who wish to be present during the tender opening may do so. Tender documents can be obtained from Mr. Gurpreet Singh, Embassy of India, Athens on any working day between **1000 hrs to 1730 hrs from 04.12.2024 to 31.01.2025**.
- 1.3 Alternatively the tender document can be downloaded from the Embassy of India, Athens website (<a href="www.indiaingreece.gov.in">www.indiaingreece.gov.in</a>) and from the Central Public Procurement Portal (CPPP) of Govt of India at <a href="https://eprocure.gov.in/epublish/app">https://eprocure.gov.in/epublish/app</a>.

## 2. INSTRUCTIONS TO BIDDERS

- 2.1 The details of terms and conditions of the job/works to be carried out, the scope of work, and the format in which bidding firms are expected to submit Technical and Financial bids is available in this document. The bidders are instructed to go through tender form thoroughly before submitting their rates. It may be noted that the bid document is liable to be ignored if incomplete information is provided.
- 2.2 All bidders and/or representatives, if they so desire, may be present at the opening of the Financial Bids by the Committee constituted by the Embassy at the time and date specified in the schedule above. Under no circumstances will bid documents received late be examined.
- 2.3 Bidding firms shall submit their quotations/rates as a one-time payment.
- 2.4 Prices/rates quoted should be in EURO and should be inclusive of all costs except VAT (i.e. VAT should be shown separately)
- 2.5 In no cases will any enhancement of the tendered rate be entertained by the Embassy of India after the selection of company/firm and award of job/work.
- 2.6 The bids shall be furnished in <u>two separate</u> covers clearly marked as "Technical Bid" and "Financial Bids", along with their respective enclosures. The two bids in separate sealed envelopes will be placed in a common envelope super scribed as "Tender for undertaking GEOTECHNICAL survey in connection with Redevelopment of Embassy Residence at Athens". Two separate cover will be sealed in the following manner:
- (i) One cover containing the Technical documents (i.e. Annexure I duly filled in) includes documentary proof etc. (technical bid)

- (ii) Second cover containing rates and duration (i.e. Annexure II duly filled in) of this offer (Financial bid)
- 2.7 <u>Please Note</u> In addition to the bid documents as described above, the bidding firm is expected to submit (a) self-attested photocopies of registration and/or survey license; (b) previous experience with references of previous clients that the Embassy may contact if required. (See Section 7 below)
- 2.8 Bids that are incomplete in any respect and/or not supported with requisite documents, will be rejected by Embassy of India, Athens.

## 3. TERMS AND CONDITIONS

- 3.1 The main terms and conditions of the job to be carried out by the successful firm shall be as follows:
  - i. The time period of completion will be 60(sixty) days, within which the works, as specified in the scope of works, can be completed. The validity of this time period is subjected to the successful firm/selected bidder showing continuous satisfactory performance. The Embassy of India will have the right to terminate the works, if the selected firm fails to show continuous satisfactory performance.
  - ii. The successful firm/selected bidder shall not subject, transfer or assign the job/works or any part thereof to another firm. In the event of the successful firm/selected bidder contravening this condition, the Embassy of India will have the right to terminate the job/works forthwith.
  - iii. The Embassy of India may at any time, by notice in writing, summarily terminate the job/works awarded without compensation to the survey company in any form in case it is felt by this Embassy of India that the company's work has not been satisfactory or in any other event where the company is facing some legal problems which may affect their performance working in this Embassy of India. The decision of this Embassy of India shall be final in this regard without any subsequent liability.
  - iv. In the event of any dispute or difference relating to the interpretation and application of the provisions of this tender, such dispute or difference shall be referred by either party to Arbitration.
  - v. The Embassy of India, Athens reserves the right to reject any or all tender without assigning any reason whatsoever.
  - vi. After evaluation of Technical bids, the financial bids of only technically qualified bidders shall be opened to identify the lowest or "L1" bidder.
  - vii. In case of failure of the company/bidder to comply with the provision of terms and conditions mentioned in this tender document, the Embassy of India reserves the right to terminate job/works awarded.

- viii. The survey company will be responsible for compliance of all applicable local laws, acts, rules by relevant statutory authorities issued from time to time in relation to the environment and man-power deployed by them for performance of the job/works under reference. The Embassy of India will be indemnified in respect of any consequences resulting from any breach or violation by the survey company of such rules, statutory obligations etc.
- ix. In the event of any violation of the laws, rules, statutory provisions by the survey company, the Embassy of India will have the right to terminate the job/works forthwith, without giving any notice or assigning any reason. The survey company shall not have claim for any compensation in such event of discontinuation of the job/works.

## 4. ELIGIBILITY CRITERIA

- 4.1 The bidder should be a company/firm duly registered with the concerned authorities in Athens for conducting Geotechnical surveys. It should have a permanent place of business in Athens. The complete postal address, telephone/mobile/email address etc. should be provided, while submitting the completed tender form.
- 4.2 The survey company should have experience in having successfully completed similar works during the last 5 years.

## 5. TERMS OF REFERENCE FOR SUBSOIL INVESTIGATIONS

- 5.1 Embassy of India intends to undertake the demolition of the existing structure and the full reconstruction of a single user high end residential dwelling at No. 58, Nikiforou Lytra, Psychiko, Athens. The facilities will include approximately 720 sq. meters of fully RCC based building along with landscaped semi open and open spaces including a fire hazard pool. The building will also have the full complement of utilities including water treatment plant, back up power generators, heating system etc. A Geotechnical investigation is required to determine the ground conditions prevalent at the plot.
- 5.2 The work shall be carried out in conformity with the provision of the latest relevant American Standard and Codes. Relevant American Society for Testing and Materials (ASTM) shall be followed.
- 5.3 Objectives of the Investigation will include the following:
  - i. To determine the allowable bearing pressure across the site
  - ii. To assess and propose the most appropriate foundation depth, type, and size
  - iii. To assess the suitability of the site for the proposed engineering works
    - iv. To foresee and provide against difficulties that may arise during construction owing to the ground and other local conditions
      - v. To enable an adequate and economical design to be prepared

- 5.4 The Subsoil Investigation will include the following:
- i. Sinking of  $2N^{0}$ . Borehole and  $8N^{0}$ . Trial Pits to a depth of 30 meters and 2.5 meters to rock respectively.
- ii. Carry out SPT and/or DCP tests as per BS Standards and collect disturbed/undisturbed soil samples at specified intervals or as directed by the Consultant.
- iii. Collect rock core samples from the boreholes and determine the Rock Quality Designation (RQD), if, hard rock is encountered during drilling.
- iv. Conduct the following laboratory tests on samples recovered:
  - a. Particle size analysis.
  - b. Atterberg Limits
  - c. Determination of Natural Moisture Content
  - d. Determination of Maximum Dry Density/Optimum Moisture Content.
  - e. Unconfined Compression Tests and density of rock
  - f. Unconsolidated undrained Triaxial tests
  - g. Chemical tests Sulphate and chloride content and pH of soil
  - h. California Bearing Ratio (CBR)
- v. Monitor water regime.
- vi. Submit factual GEOTECHNICAL investigation reports along with borehole and trial pits location plan, detailed laboratory, and field test results with appropriate graphs/plots, and pertinent information required by this specification.

#### 6. **DETAILED REPORT**

On completion of all field and laboratory testing, a detailed report shall be prepared and submitted to the Supervising Consultant and/or Embassy of India, Athens. The report shall include (but not by way of limitation):

- i. A plan showing the position of all boreholes and trial pits at a particular location with geo-referenced coordinates.
- ii. A description of the procedures of investigation and testing employed and a list of equipment used.
- iii. Detailed borehole and trial pit logs, subsoil sections, laboratory, and field test results both in tabular as well as in graphical form, showing variations of each of the soil properties with depths in each borehole.
- iv. Field and laboratory test results along with graphs and tables used for computation.
- v. The stress-strain diagrams as well as Mohr circle envelopes for unconfined compression tests, triaxial tests, and crushing strength of rock sample.
- vi. Modulus of elasticity calculated from the crushing strength of rock.
- vii. Recommendation regarding the type of cement to be used and any treatment to the concrete based on the chemical composition of soil and sub-soil water.
- viii. Any other Information of special significance encountered during the Investigation and likely to have a bearing on the design and construction of foundations.
- ix. Full colour photographs of field and laboratory activities and all the core boxes shall be included in each copy of the report.

A copy of the detailed report shall be submitted to the Supervising Consultant and/or Embassy of India, Athens for review and approval in soft copy and the final report shall be submitted thereafter in **three full colour copies**.

# 7. ADDITIONAL INFORMATION TO BE PROVIDED ALONG WITH TECHNICAL AND FINANCIAL BIDS

- 7.1 In addition to their Technical and Financial bids, bidding firms may also provide the following additional information:

- 7.3 Human resources to be deployed (a) CVs of proposed team; (b) Details of any third collaboration or services that will be outsourced.
- 7.4 Methodologies and Approach: A brief written description of how the project is intended to be undertaken should be included covering in particular
  - a) An organization chart of the project team showing team structure with roles and responsibilities
  - b) Details of an internal quality management system
  - c) A description of how the drilling and sample collection process is to be managed.
  - d) Programming and Reporting format.
  - e) Sustainability and Environmental Health and Safety (EHS).
- 7.5 Earnest Money Deposit (EMD) & Bid Security Declaration (BSD)

The bidder must submit Earnest Money Deposit (EMD) of **Euro 500.00 (Euro Five hundred only)** in the form of Bank Guarantee and Bid Security Declaration (BSD). The format of Bank Guarantee Proforma for EMD and BSD are attached as Annexures – III & IV respectively.

## 8. INSTRUCTIONS FOR TECHNICAL PROPOSAL SUBMISSION

## 9. INSTRUCTIONS FOR FINANCIAL PROPOSAL SUBMISSION

- i. Financial Bids are to be submitted in a separate envelope to the Technical proposal.
- ii. The quote price should be provided in clear terms, with a breakup of the costing. Taxes applicable should be shown separately and clearly. Any change in taxes or levies made by the Competent Authority after finalization of tender will be applicable at the time of billing. Bids having any hidden costs or conditional costs are liable to be rejected.
- iii. Prices quoted by the Bidder shall be fixed and no variation will be allowed under any circumstances except that of change in tax rates.
- iv. Prices shall be quoted in EURO
- v. Payment: 100% amount of the accepted bid shall be released after the completion of job.
